## CONSENT AND RELEASE AGREEMENT

The undersigned parent or guardian ("Undersigned") hereby give permission for the above-named child ("Child") to participate in all activities at RAH! The Undersigned parents or guardians, on behalf of the Child, assume the risks of all activities at RAH!, and hereby release RAH! and its owners, officers, managers, employees, instructors, and other personnel (collectively, "Releasees") from any and all claims, causes of action, damages, or liability for any injuries suffered by the Child while participating in activities at RAH!'s facility or activities otherwise provided by RAH!, whether such injuries arise as the result of negligence of one or more of the Releasees, a defect in any equipment used at the facility, or otherwise. The Undersigned agree not to sue RAH! or any of the Releasees for damages or other relief arising from any illness or injury suffered by the Child while engaging in activities at or sponsored by RAH!

The Undersigned agree to support and abide by, and to instruct the Child to support and abide by, the gym rules and policies posted in the gym. The Undersigned certify that the Child is physically, mentally, and emotionally capable of participating in the activities provided at RAH!

The Undersigned understand that participants are expected to carry their own accident and medical insurance. The Undersigned agree to be responsible for any medical bills incurred as a result of any illness or injury the Child may suffer while at RAH! The Undersigned understand that, in the event the Child suffers any injury or illness while at RAH!, RAH!'s personnel will attempt to contact the Undersigned but, in the event that RAH! is not able to reach them, the Undersigned authorize RAH! to administer first aid and/or obtain medical treatment for the Child.
